## Wamego's ready to go

Community volunteers have slowly transformed Wamego into its summertime alter ego, "Boomtown USA."

Each year, the city's Fourth of July fireworks display dazzles crowds with innovative pyrotechnics and a musical soundtrack to enhance the overall sensory experience.

Chris Hupe, who leads Wamego's pyro crew, said the show will use a new software platform to add professional-level lighting effects to the fireworks.

"There's some technology that we're going to be dabbling with this year that we'll start to unveil in a very small form, but it will be new on site," he said. "It's really pushing the envelope of synthesis between pyrotechnics and other types of special ef-

Hupe said the pyro crew consists of 39 trained pyrotechnicians, all of whom volunteer their services on an annual basis.

"We're essentially running a business without being a business," he said. "It's lining up, finding out who's available, who's retiring, who do we need to identify to step in and train."

# County moving in arson case

The county may have identified suspects in the Walmart arson case, according to County Attorney John Paul Washburn, who on Monday updated the commission on the status of sev-

eral ongoing cases. The June 13 arson caused approximately \$1.2 million in damages and caused the store to be closed for several days.

Washburn told commissioners a meeting was planned later that day to review security footage with the lead detective, but they believe they have already identified a suspect. He thanked the Riley County police force, saying they "did a good job working on that case."

Additionally, he said that a hearing

was to take place the following day for the June 22 attempted murder case north of Wamego and that the victim is "recovering the best she can."

Although the case is still under investigation, Washburn stated the "public deserves to know we are moving forward."

In other updates, Washburn said his department is continuing to stay busy preparing for the Rock The Plains music festival in August. They expect an increased case load because of the festivities and have cleared Oct. 2 to solely deal with its

caseload. A focus has also been placed on attending training and community meetings such as Safe Kids, Mothers Against Drunk Driving, Bikers Against Child Abuse, and USD 320 school district. They have also partnered with several law enforcement officers, spending time with them to 'get to know the officers as well as their philosophy and obtain a greater appreciation."

The county attorney's office is now fully staffed after three months where "two people were doing the work of four," according to Washburn. There are hopes of possibly getting a legal intern but that would be in the coming years. Washburn thanked the team for "really stepping up."

## **Bond lowered in** attempted murder case

Pottawatomie County District Judge Jeff Elder Tuesday lowered the bond and set a second status hearing for the Onaga woman charged with attempted second degree murder.

The charge stems from a June 22 incident where Dana Murray, 43, (identified as Dana Blume in the initial press release) had intentionally run over Kara Murray, 52, Wamego, with a vehicle on Pauling Run Road. Kara Murray was subsequently hospitalized with severe injuries.

In Tuesday's hearing, Dana Murray's attorney Laura Ingels, while acknowledging the seriousness of the offense, requested the \$250,000 bond be lowered to

"That's still a significant bond that will ensure that she will appear at court," Ingels said. "She doesn't have any prior felonies. She doesn't have any prior failures to appear. Her plan is to return home, if there is no objection to that. She does have children. She is employed, or at least I believe she is. She has lived in Kansas for 25 years. Her family is all in Kansas.

## One-car crash injures **Hutchinson** man

A Hutchinson man was seriously injured last Friday in a one car crash, according to the Kansas Highway

The KHP report said Zachary Lynn Stinson, 43, Hutchinson, was driving a 2003 Toyota Corolla southbound on K13 at Cedar Creek Rd. at 2:05 p.m., June 27, when he entered a curve in the roadway. The car went left of center, entering the northbound lane of travel. There it encountered a north bound car, causing the driver to correct and enter back into the southbound lane. The driver lost control and the car went on to the east shoulder, colliding with two guard rails, then coming to rest after striking a tree.

According to the report, Stinson was transported to an area hospital for suspected serious injuries. He was wearing a seatbelt.

The accident caused authorities to close the road at K-13 and Cedar Creek for approximately four hours.
