Loyd, her parents Glen and Opal (McSpadden) Logsdon, and her grandson Gregory Arbuckle.

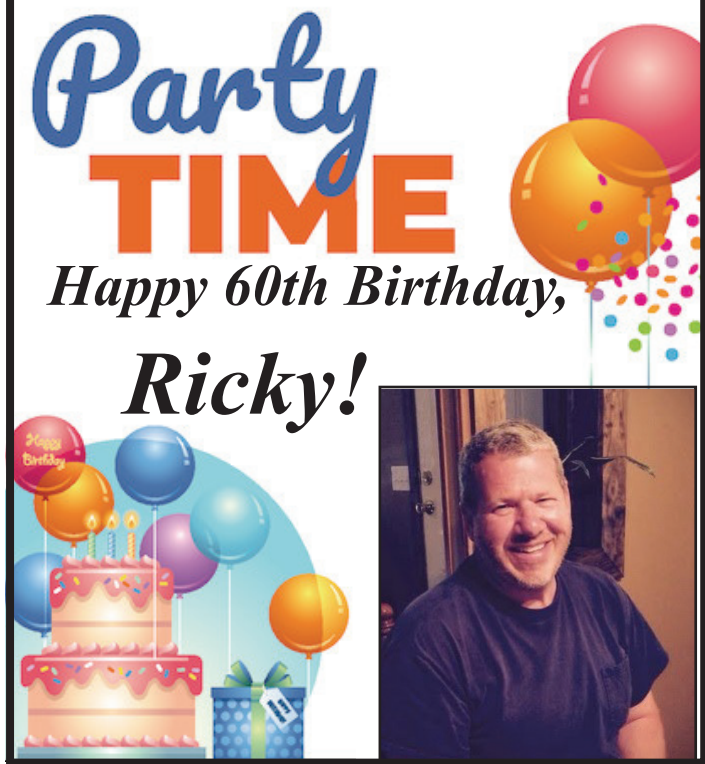
Helen was a member of the Broadway Christian Church and the Riverside Christian Church in Wichita, Kansas.

You, and each of you, are hereby notified that SEK Energy, LLC has filed an application to commence the disposal of salt-water into the Arbuckle formation utilizing the Burghart #SWD located in Section 34 of T27S-R15E, 1269' from the East section line and 4037' from the South section line of the section in Wilson County, Kansas. The water will be disposed at a depth of 1505' to 1644', at a maximum operating pressure of 200 psi and at a maximum disposal rate of 4000 BBL per day.

Any persons who object to or protest this application shall be required to file their objections or protests with the Conservation Division of the State Corporation Commission of the State of Kansas within thirty [30] days from the date of the publication. These protests shall be filed pursuant to Commission regulations and must state specific reasons why the grant of the application may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas.
