RESOLUTION #2025-004

A Resolution approving a Special Use to establish a solar energy generation facility (solar field) in the Agricultural District on certain lands located in Wilson County, Kansas, under the authority granted by the Zoning Regulations of the County.

Be it resolved by the Board of County Commissioners of Wilson County, Kansas:

Section 1. That having received recommendation from the Wilson County Planning Board on Case No. SU-2024-002, and proper notice having been given and hearing held as provided by law and under authority and subject to the provisions of the Zoning Regulations of the County as originally approved by Resolution #819, a Special Use is hereby authorized to establish a solar energy generation facility (solar field) in the Agricultural District.

Legal description: On file in the Zoning Administrator's Office.

General location: SE corner of 900 & Reno Roads, South to 800 Road, East to Scott Road, North to 900 Road, and West to US-75 Highway.

Such Special Use is subject to the following condition(s):

1. Per the Conditions of Approval set forth by Attachment A.
2. Per the Findings of Fact adopted by the County Commission on April 9, 2025.

Section 2. That upon the taking effect of this Resolution, a notation of such Special Use case shall be entered and shown on the Official Zoning Map(s) as previously adopted by reference.

Section 3. That this Resolution shall take effect and be in force from and after its adoption and publication once in the official county newspaper.
