### Grisiers to celebrate 50th



Joe Grisier and Karen Brazil were Yates Center High School sweethearts. They married March 22. 1975,in the Presbyterian Church, by Reverend Yoon. These were the days when newly married couples were "Chivalried", or taken from their home to push each other around the Yates Center Square on a wheel barrow. A few firecrackers were even accidently fired off!

Joe R. Grisier graduated from Yates Center High School in 1969. Concert, jazz and marching band were important for both Joe and Karen as both played in the trumpet section. For many years Joe held the two mile cross country record as it later was changed to metric. He later ran for Allen County Community College Cross Country Team where he attended two years prior to completing two years at Kansas State University in Agronomy. Joe joined his father for farming and care of livestock where he continues to team with the "Grisier Farms", southeast of Yates Center.

All of Joe's life he has served in his church and helped with the founding of Christian Liberty Fellowship Church, in Yates Center. He served over 30 years in the Gideons International min-Full Gospel Businessman's group as well as ten years on the Board of the Woodson County Soil Conservation Service and Lion's Club. With a passion for "no-till farming" and agronomy, Joe served as superintendent of the Crops and Gardening Departments of the Woodson County Fair for many years. Joe was known to express gratitude for the insights shared by the serving Gary judge: Kilgore, Agricultural Agent for southeast Kansas.

Karen grew up north of Yates Center and attended the Pleasant View School District 84 near Highway 75. She was active in the FHA, Kayettes and Pep Club prior to graduating from the Yates Center High School in 1972. After obtaining her LPN license, Karen worked for Autumn Manor Nursing Home for a year, and four years at Allen County Hospital, in Iola.



Many may remember Karen as the office nurse for John D. Atkin MD at the Yates Center Medical Clinic, where she served for 31 years.

Like Joe, Karen served the community through her church, Gideons International, Full Gospel Business, and the Lion's Club, of Yates Center. She continues to help families with health care needs but current day, passionately pursues the nurturing of her daughterin-law, sons and three grand-

Joe and Karen's lives have not been without challenge. When their first son Chris was six weeks old, their home was destroyed by fire on a cold January night in 1975. Only their lives were spared by awaking to the cough of their infant son. After living in Yates Center for ten years, they moved back to live in the renovated farm home of Joe's maternal grandparents.

Current day, Joe and Karen do not stop living active lives. Joe is a Master of Animal Husbandry and gardening. Karen could easily qualify as a "Master Gardener" as she spent four years working for "Arnold's Greenhouse", and savors time in her own garden and flower beds.

Their legacy includes sons Chris Grisier, of Yates Center, and Todd (Tara) Grisier, of Andover. Grandkids include Abigale, Lorali, and Kemper Grisier.
