ANIMAL CONTROL OFFICER. The Animal Control Officer is a full-time position under the supervision of the Yates Center Safety Committee. This position deals with domestic animals and helping to enforce City ordinances regarding the same. The essential functions for Animal Control include: Maintaining the City of Yates Center Animal Control Shelter per State regulations. Picking up stray dogs and cats when complaint is received. If the animal is vicious the kennel needs to be tagged. Animals are to be scanned for a micro-chip if possible. Providing as necessary, food, water, shade, and heat for animals in the shelter. Animals in the shelter are to be

checked daily. Providing a log sheet with: description of animal; date, time, and address where animal was picked up; any information regarding collar and tags present when animal was picked up; kennel number where animal is housed Providing pictures of the animal to city hall for public notification. Minor repairs to shelter. Examples would be replacing shade tarps, locks, or mud flaps on runs. Transporting animals to non-kill shelters or feral cats to farms requesting them. Transporting animals for vet services. If employee is to be out of town, city hall needs to be notified so arrangements can be made to cover position. A city vehicle will be provided for animal calls if available. Vehicle, animal carriers, traps, and misc. equipment is to remain at city hall unless being used for an animal call. Animal control officer is expected to help the police department with vicious animals, including being properly trained how to use the tranquilizer gun. A valid driver’s license is required. To apply, come to City Hall, 117 E Rutledge, and fill out an application during business hours of 8 am – 5 pm Monday through Friday.

DUST CONTROL PROGRAM FOR RURAL AREAS

Woodson County Road & Bridge Department is now taking orders for the application of “DustGard” applied to county roads for the purpose of dust control. This will be for County residents at the cost of \$1.65 per foot with a minimum of 300’ and additional footage is available. Fee is to be paid in full prior to application; deadline to order is March 28, 2025, by 3:00 p.m. If interested, please contact the Road & Bridge Department Office for more information or to pick up an application at (620) 625-8625. You may also print the application from the newspaper and return it the Road & Bridge Department at the courthouse with your payment in full.

DUST ABATEMENT PROGRAM

Woodson County will continue the program to reduce the amount of road dust in front of rural homes for residents or land owners who wish to participate. A date will be set for later this year to apply the Liquid Magnesium Chloride dependent on interest. This application of Magnesium Chloride shall be a minimum of 300’ at a cost of \$1.65 per lineal foot of treated road at the cost of the applicant. Counties are NOT required to provide dust control on roads in Kansas.

WHAT IS MAGNESIUM CHLORIDE?

Magnesium Chloride is a compound refined from the waters of the Great Salt Lake in Utah. The liquid compound is sprayed on the Road Surface and is allowed to penetrate to a depth of approximately 3 inches. The major property of the material is such that it attracts moisture which stabilizes the aggregates on the Road Surface. Each new introduction of additional moisture in the form of high humidity or rainfall reconstitutes the material and re-binds the aggregate. Unlike the Asphalt previously used for Dust Control, Magnesium Chloride is applied for one season application only and will be re-bladed as needed to remove any small pot holes and rough areas as required for normal road maintenance.

APPLYING MAGNESIUM CHLORIDE

Liquid Magnesium Chloride will be sprayed onto the Road. It will usually take one to two hours for the liquid material to soak into the Road. Vehicles driving through the recently applied Magnesium Chloride may be splattered but this can be easily removed with water. Due to the large number of Dust Control Strips to be applied, the County will not be able to erect barricades and large warning signs. Drivers will be able to see the darkened and moistened area ahead. Vehicles should drive slowly in the material for the first several hours. The County will NOT clean or pay for cleaning cars.

WHAT HOUSES ARE ELIGIBLE?

Any rural home in Woodson County, outside of an incorporated area, that is located within 300 feet of a rock or gravel road, is eligible for Dust Control treatment. **Neither refunds nor re-treatments will be made should the DustGard fail to perform to your expectations.**

WHEN AND HOW TO APPLY

Anyone wishing to have Dust Control treatment placed in front of their residence should fill in the attached form and return it to the Woodson County Road & Bridge Office at the Courthouse at 105 West Rutledge in Yates Center. **Each application request must be accompanied by a check made out to the Woodson County Road & Bridge for the full cost computed at the rate of \$1.65 per lineal foot treated. ** The deadline for submitting applications is 3:00 P.M., Friday, March 28, 2025. All applications received after the deadline will be returned. Additional information may be obtained by calling Woodson County Road & Bridge Dept. Office at 620-625-8625 ext. 5.
