# **Protect yourself from** tick borne illnesses

As we enjoy the warmer weather and spend more time outdoors, it's important to be aware of the risks posed by tick borne illnesses here in Kansas. While hiking, fishing, gardening, or simply enjoying our backyards, we may come into contact with ticks carrying harmful bacteria and viruses. In Southeast Kansas, tick borne diseases such as Ehrlichiosis, Spotted Fever Rickettsiosis includes Rocky Mountain Spotted Fever), Tularemia, and Lyme disease have all been reported.

early spring through late fall and can be found in grassy, wooded, or brushy areas, places that are abundant in our rural landscapes. While not all ticks are infected, it only takes one bite from the right tick to transmit a potentially serious illness. Tick Common borne

Illnesses in Kansas Include:

Ehrlichiosis: Symptoms often include fever, headache, fatigue, and muscle aches. It is caused by bacteria transmitted primarily by the lone star tick.

Spotted Fever Rickettsiosis (including Rocky Mountain Spotted Fever): Look for fever, rash, headache, nausea, and muscle pain. If untreated, this can become severe.

Tularemia: This can be transmitted through tick bites or direct contact with infected animals. Symptoms vary but may include fever, skin ulcers, and swollen lymph glands.

Lyme Disease: Although less common in Kansas, cases do occur. Look for the classic bullseye rash, along with fever, fatigue, and joint pain.

Tick Bite Prevention: How to stay safe outdoors.

Protecting yourself and your loved ones from tick bites is the best way to prevent tick borne disease. Here are some important prevention strategies to fol-

Dress Smart: Wear long sleeves and long pants. Tuck your pants into your socks or boots to keep ticks from crawling inside. Choose light-colored clothing to make it easier to spot ticks.

Use effective repellents: Apply EPA-registered insect repellents that contain DEET, picaridin, IR3535, or oil of lemon eucalyptus. Treat clothing and gear with products con-

taining 0.5% permethrin for added protection.

Stay on the trail: Avoid walking through tall grasses and brush. Stick to the center of trails when hiking.

Check for ticks often: Do frequent tick checks, especially on children and pets. Pay close attention to warm, hidden areas like the scalp, ears, underarms, waistline, and behind knees. Bathe or shower within two hours of being outdoors to help wash off ticks and more easily

Create a tick-safe yard: Keep lawns mowed, remove leaf litter, and stack wood neatly. Place a barrier of wood chips or gravel between lawns and wooded areas to restrict tick migration into recreational

Protect pets: Use veterinarian-recommended flea and tick prevention products yearround. Check pets for ticks daily—especially if they spend time outdoors.

Remove ticks safely: Use fine-tipped tweezers to grasp the tick as close to the skin's surface as possible. Pull upward steadily and clean the area with soap and water.

Avoid twisting or squeezing the tick. Do not use petroleum jelly, heat, or nail polish to remove it.

Kansas Tick Surveillance Project: Thanks to a collaboration between the Kansas Department of Health and Environment, Dr. Erin Petro, State Public Health Veterinarian, Dr. Elizabeth Smith, State Public Health Entomologist, and Harold Wilcox III, Vector Borne Disease Medical Investigator, a Tick Check Station has been placed at Cross Timbers State Park, at Toronto Lake.

This station is designed to educate visitors about tick safety and encourage self-checks after spending time outdoors. It also includes a tick specimen collection jar. If you find a tick on yourself or your pet, you can place the tick in the jar, these specimens are sent to the state laboratory for testing. This valuable program helps provide real-time data on the types of ticks in our area and the diseases they may be carrying, helping inform public health efforts across the state.

The Woodson County Health Department is committed to supporting community aware-

ness and prevention of vectorborne diseases. If you develop a fever, rash, or other symptoms within a few weeks of a tick bite—or after spending time in tick-prone areas—seek medical attention promptly.
