Another well-known Yates Center citizen was Alton Aronhalt, a 92-year-old Old Time Fiddlers and Pickers member who tuned up his fiddle and played a special solo, Happy Birthday, Yates Center, for the Celebration. He lived alone, gardened each morning, and rode his trike to the Senior Center afternoons to visit with his cronies.
