Their first business was bulk fuel. The first load of grain was flax. The first Board members were C.R. Miller, John Glades, Truman Weston, Howard Gibbs, Thomas Broadman, Tom Smith, Sr., and Clint Cope. The first manager was Si Rieter. Founded in 1950, the Co-Op had 117 members and total assets of \$13,300.
