State law requires a publication fee of \$16.00 be assessed against each name listed.

Some of the names listed below in this legal publication may have already paid their real estate taxes or may be awaiting results of a tax protest hearing before paying second tax taxes due. Unfortunately, it is impossible to delete those names from publication because of statutory requirements.

Although these procedures are required by law, I regret any undue embarrassment this publication may cause those who have paid their taxes after the publication or list preparation deadlines or who are still awaiting tax protest decisions.
