AN ORDINANCE

AMENDING CHAPTER 3,

ARTICLE 1, SECTION 103

OF THE CODE OF THE CITY

No person shall drink or consume alcoholic liquor on city-owned or public property. This prohibition shall not apply to the following City-owned properties:

- a) Crawford County Fairgrounds,b) Crawford Hills Municipal Golf Course,
- c) Civic Center, and
- d) Veteran's Park

This prohibition shall not apply to the following properties and/or locations located within the City limits:

- a) Hospital District #1 of Crawford County, d/b/a Girard Medical Center during social functions duly approved by the board of directors of the Hospital District.
- b) From 10 am to 8 pm along the parade route for the Chamber-hosted Fall Festival celebration which occurs for one day annually in the fall on a Saturday. Glass containers are not permitted.

Section 2. This Ordinance shall be in full force and effect upon its passage, approval and publication according to law.
