## Osage County Commission approves comprehensive plan

LYNDON — The Osage County Commission met on the evening of June 24, to address critical local governance issues, including the adoption of the county's comprehensive land use plan, payroll adjustments, and infrastructure funding. Commissioners Les Holman and Heather Kuder were present in person, while Brandon Smith participated remotely by phone. County Clerk Michelle Morris was present as well, and County Counselor Josh Ney was available via phone, if needed.

Public comments set the tone

for the meeting, with residents focusing heavily on land use policies, particularly concerning renewable energy projects. Jim Foster, a Carbondale resident, expressed concerns about leases issued by NextEra Energy for green power projects, arguing that they stripped landowners and regulators of control. He criticized the Payment in Lieu of Taxes (PILOT) program, calling it a "pie crust promise" that could collapse if project names changed, leaving the county without anticipated revenue. Foster also emphasized the need for greater

township involvement in land use planning, and highlighted the lack of funding for maintaining roads near a power transfer station, which sees heavy truck traffic.

Another Carbondale resident, Diane Hen?, supported the approval of the comprehensive plan presented on June 17, asserting that it addressed many of the concerns raised by Foster. Joe Hyde, a resident from south of Osage City, opposed a proposed solar farm spanning 20,000 acres, citing its potential to disrupt ranching, farming and wildlife, as well as

environmental issues like water runoff, hail damage to panels, and the challenge of disposing non-recyclable solar panels after their 30-year lifespan.

The centerpiece of the meeting was the discussion and adoption of the county's comprehensive plan under unfinished business. The commission reviewed proposed amendments to the plan, which had been in development for over two years and was presented on June 17. Smith proposed two specific changes: First, amending Page 15 to clarify that Olivet purchases water from Rural Water District No. 3, not from wells, ensuring accurate representation of water sourcing; and second, removing bullet point five on Page 84, which encouraged waste stream reduction through recycling promotion. Smith argued that the county's recycling program was costly, as it involved transporting materials to a separate dump, and removing the bullet point would not preclude private recycling efforts, but would avoid committing the county
