The audit reported no 2023 budget violations. Recurring internal control findings remain, includ-

Untimely or incomplete bank reconciliations between the treasurer and clerk offices.

■ Inconsistent completion of the daily "envelope" reconciliation process that ties receipts, deposits, and disbursements together.

■ Gaps in tax roll reconciliation (abstract, collections, and outstanding delinquencies).

Occasional untimely deposits at the health department.

Documentation responsiveness from a handful of outside entities

that receive county appropriations.

Loyd recommended the county formalize several financial reporting and internal control policies, assign owners to each finding, and track remediation progress. He also noted the American Rescue Plan Act (ARPA) fund was closed out by Dec. 31, 2024, following final entries and reconciliation.

During the hearing, commissioners confirmed that adopting the budget at RNR fixes the overall mill levy and spending

authority; departmentlevel appropriations and line items can be adjusted administratively during the fiscal year as needs and updated numbers are confirmed, provided total authority is not exceeded.

Public comment was opened and closed with no speakers. The commission approved the agenda, adopted the county and sewer district budgets for submission to the state, and adjourned the hearing. The regular meeting followed after a short recess.
