Wine reappointed as chief judge

TOPEKA — The Kansas Supreme Court has reappointed 28 chief judges for terms that begin Jan. 1, 2026, and end Dec. 31,

Among those reappointed was Chief Judge Taylor Wine, who was reappointed in the 4th Judicial District, which is composed of Anderson, Coffey, Franklin, and Osage counties. He has served as a district judge since 2018, and chief judge since 2019.

Wine graduated from Pittsburg State University and Southern Methodist University Dedman School of Law. He was in private practice before he was appointed district magistrate judge and later district judge.

Each of the 31 judicial districts in Kansas has a

chief judge. In addition to their judicial responsibilities, the chief judge has general control over case assignments within the district, as well as general supervisory authority over the administrative and clerical functions of the court.

Osage County Commission

County commission addresses appraisal staffing, IT upgrades, banking procedures

LYNDON — The Osage County Commission met Tuesday, Oct. 21, with Commissioners Brandon Smith and Heather Kuder present. County Clerk Michelle Morris and County Counselor Josh Ney also attended in person, while Commissioner Les Holman participated by phone.

Commissioners approved several additions to the meeting agenda, including a conference call with the Kansas Department of Revenue's Property Valuation Division (PVD) regarding the county appraiser's office, a purchase order from the county treasurer, and multiple executive sessions.

During public comment, a patron of rural Carbondale presented a petition signed by about 16 residents requesting the county post 30-mph speed limit signs along 217th and 221st streets, near U.S. Highway 75 and the Carbolyn Park area. He cited increased traffic from highway detours and commercial delivery trucks, as well as safety concerns caused by hills, limited sight distance, and frequent use by horsedrawn buggies.

Commissioners discussed jurisdiction over township roads and asked Counselor Ney to research whether the county could legally impose speed limits in that area. Sheriff's office representatives said they would review any accident data and traffic complaints for the road before the commission takes action. If jurisdiction is confirmed, Ney will draft a resolution establishing posted limits.

County Treasurer Becky Holmberg presented a purchase order from Computer Information Concepts (CIC) for a one-time fee of \$1,260 to merge two county image-server databases. The change will consolidate digital records shared by the clerk's, treasurer's and register of deeds' offices to ensure consistency across departments. After discussion about available fund balances, commissioners voted to pay the cost from the county's computer fund (contractual services line item).

Commissioners approved the promotion of Rebecca Bronson from clerk to deputy county treasurer, increasing her pay from \$18 to \$20 per hour, effective Oct. 21.

The promotion fills a vacancy in the treasurer's office.

The board also approved three personnel resignations from the sheriff's office and authorized the hiring of a corrections officer, Nicholas Trego with a starting wage of \$20.13 per hour, effective Oct. 21.

The commission held an extended conference call with the PVD director and compliance supervisor, to discuss the county's appraisal office status and compliance deadlines.

PVD staff reported that the county's interim appraiser, Michelle Rooks, faces a Nov. 3 deadline to complete required sales and land-analysis studies, but lacks the certifications to perform some technical work. To avoid falling behind, the state offered to send staff to assist with market analysis and compliance reports.

PVD officials advised that the county must have a qualified, RMA-certified county appraiser appointed by Jan. 1, 2026. The state's interim appointment
