A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARBONDALE, KANSAS AU-THORIZING THE ABATEMENT OF PROPERTY LOCATED AT 333 Osborn, Carbondale Kansas 66414, FOR VIOLATIONS OF CITY CODE.

RESOLUTION 2025-27

A RESOLUTION ADOPTING A TRANSIENT GUEST TAX PURSUANT CHARTER RESOLUTION C-2025-15

WHEREAS, on July 15, 2025, the Osage Board of County Commissioners passed Osage County Charter Resolution C-2025-15 thereby electing to exempt itself from the provisions of K.S.A. 12-1697 which authorizes the governing body of any county to levy a transient guest tax at a rate not to exceed two percent (2%) upon the gross receipts derived from or paid by transient guests for sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel or tourist court; and

WHEREAS, Charter Resolution C-2025-15 took effect after 61 days after final publication and no petition for a referendum was filed pursuant to K.S.A. 19-101b;

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Osage County, Kansas:

Section 1. The County of Osage, being exempt from the provisions of K.S.A 12-1697 through the exercise of its home rule charter resolution authority, hereby elects to levy a transient guest tax at the rate of six percent (6%) upon the gross receipts derived from or paid directly or through an accommodations broker by transient guests for sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel or tourist court.

Section 2. This Resolution shall be published once a week for two consecutive weeks in the official county newspaper.

Section 3. This resolution shall become effective after publication in the county newspaper.

Section 4. The collection of any county or city transient guest tax authorized to be levied pursuant to this resolution shall commence on the first day of the calendar quarter next following the 30th day after the date of the receipt by the department of revenue of the resolution or ordinance authorizing the levy of such tax.
