Commissioners agreed to make annual payments, rather than paying in full, noting the sheriff's vehicle fund held more than \$162,000 as of mid-November. They approved Purchase Order 4055 for the \$23,000 first-year payment from that fund.

Wells also discussed the looming need to replace body cameras and in-car cameras, and suggested that unexpected jail housing revenue, currently deposited into the general fund, may help cover that future cost. Commissioners requested a detailed report breaking out the specific line item for housing reimburse ment.

A significant portion of the meeting was spent in two attorney-client executive sessions. Early in the meeting, they met with Ney and Wells to discuss "ongoing agency operations," returning with no action taken. Later, they entered another session for "legal advice for policy and procedure," which was extended three times, with no action taken after each return to open session.

Two tied city council races from the November general election were decided "by lot," as required by Kansas law. For the City of Melvern, commissioners assigned heads to Frank Warner and tails to Jerry Beeman, with Beeman taking the seat. For the City of Scranton, heads was assigned to Tim Nedeau and tails to Allison Vanderord, in which Nedeau earned the seat. Certification forms for both were signed. Commissioners approved Purchase Order 4112 for the county's "No Wait Inside" annual appointment-scheduling subscription in the amount of \$5,400. Harrison said the system is used by several offices for scheduling and queue management. Commissioners asked for usage statistics ahead of future renewals.

The board also approved two emergency vehicle designation applications for vehicles used by Dylan Filkins.

Commissioners reviewed four applications for the county appraiser vacancy. With Morris absent, Harrison provided documents for review. Commissioners agreed that one applicant did not meet their needs, and directed staff to schedule interviews next week with two candidates - one by phone and one in person - during the commission meeting.

In other action, commissioners:

Approved a payroll action form converting County Counselor Josh Ney from independent contractor to a full-time county official at an annual salary of \$71,200, effective Dec. 12.

Agreed to seek proposals for the 2024 county audit rather than immediately accepting an engagement letter from The Lloyd Group. Ney will draft an RFP for review next week. The clerk's office will receive submissions, with Ney listed as the contact for technical questions.
