ORDINANCE NO. 469

AN ORDINANCE PROVIDING FOR AN INCREASE IN WATER RATES FOR THE CITY OF MELVERN AND AMENDING ORDINANCE NO. 465. BE IT ORDAINED BY THE GOVERN-ING BODY OF THE CITY OF MELVERN, KANSAS, THAT OR-DINANCE 465, WHICH IS NOW IN EFFECT, SHALL BE REPEALED AND AMENDED AS FOLLOWS:

SECTION I. RATES: The following monthly rates are hereby established and shall be paid for water furnished and sold by the City of Melvern, Kansas:

Subsection A: Beginning lanuary 1. 2026. residents whose dwelling is located within the corporate limit of the City of Melvern, Kansas: \$25.00 base rate \$1.30 per hundred gallons

Withing this subsection, the

term "resident" means each metered location, whether or not more than one family or dwelling is serviced by said meter. The minimum monthly water charge for all residents

shall be \$25.00. Subsection B: Beginning January 1, 2026, residents whose dwelling is located outside the corporate limits of the City of Melvern. Kansas: \$32.00 base rate

used Within this subsection, the term "resident" means each metered location, whether or not more than one family or dwelling is serviced by said meter. The minimum monthly water charge for all residents

shall be \$32.00.

SECTION II. REPEAL AND AMENDMENT: Any further scheduled increases in Ordinance No. 465 shall be repealed. All other aspects of Ordinance No. 465 not changed above shall remain in full force and effect.

SECTION IV. This Ordinance shall take effect from and after its adoption and publication in the official city newspaper.
