 Individuals desiring to become a candidate for one of these offices must reside within and be a qualified elector of the city.  
 Applications for candidacy are available at the Cloud County Clerk's Office and must be completed and filed by 12:00 o'clock noon on June 1, 2026. A filing fee of \$20.00 will be required from each applicant unless such application is accompanied by a petition of the qualified electors of the city. No applications will be accepted after that time and date. By the same token, no candidate having filed for office shall be allowed to withdraw his candidacy after this deadline. A primary election will not be held unless there are more than ten (10) candidates for the councilmember positions being vacated. In the event a primary election is required, it will be held on August 4, 2026 for the purpose of eliminating those candidates over and above that authorized by law.
