RESOLUTION NO. 2026-07
A RESOLUTION ESTABLISHING FEES AND RATES FOR STORM WATER UTILITY SERVICE FOR THE CITY OF DODGE CITY.

WHEREAS, for the peace, health, safety, and welfare of the citizens of Dodge City, it is deemed necessary for the City to provide Storm Water Utility Service to its citizens; and WHEREAS, it is necessary for each and every resident of the City of Dodge City to pay a fair and equitable share of the cost of operation for said utility; and NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Dodge City, Kansas, that the following shall be the fee schedule for Storm Water Utility Service in Dodge City.
Section 1: REPEAL: Resolution 2025-13; adopted on the 17th day of March, 2025, is hereby repealed.
Section 2: RATES ESTABLISHED:
 All properties are assessed \$1.71 per Drainage Unit per month. A Drainage Unit Has been established by Charter Ordinance No. 33.
Section 3. EFFECTIVE DATE: The rates specified hereinabove shall be come effective during the month of April, 2026 as appropriate and upon its adoption by the City Commission and publication in the official City newspaper.
