Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality construction permit. **KBK Industries LLC** has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300. Emissions of (volatile organic compounds (VOC), particulate matter (PM), PM with less than or equal to 10 microns in aerodynamic diameter (PM10), PM with less than or equal to 2.5 microns in aerodynamic diameter (PM2.5), and hazardous air pollutants (HAPs) were evaluated during the permit review process.

KBK Industries LLC, PO Box 216, Rush Center, Rush County, Kansas 67575, owns and operates a fiberglass manufacturing facility located at North Facility, 1914 Highway 183 and South Facility, 2537 Highway 96, Rush Center, Rush County, Kansas 67575, at which one (1) chop hoop tank winder is to be installed, and one (1) chop hoop tank winder that was installed in 2020 is to be retroactively permitted.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to **Alexandra Mohn**, KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than noon on **May 4, 2026**, in order for the Secretary of Health and Environment to consider the request.
