Godly Love

1 Corinthians 13:1 "Though I speak with the tongues of men and of angels, and have not charity, I am become as sounding brass, or a tinkling cymbal."

Last week I started in with Godly love, Agape, which is not something taken lightly like most of us do with love in modern times. When the Lord Jesus Christ was dealing with Peter after the Resurrection in John chapter 21 about whether he loved Him, Jesus, more than the fish he had caught, we see both forms of the word love used here. John 21:15 "So when they had dined, Jesus saith to Simon Peter, Simon, son of Jonas, lovest thou me more than these? He saith unto him, Yea, Lord; thou knowest that I love thee. He saith unto him, Feed my lambs." Here in this verse the Lord uses the word agape, which is translated "lovest" and Peter responds back with "thou knowest I love thee, the word love is phileo, which is to be a friend of or affection for. This may sound similar to each other, but the love you have for God and your spouse, should be a love that is willing to sacrifice, suffer for them, and not easily provoked. The Lord asked Peter again the second time with the same word agape, and again Peter responds with phileo, the love for a friend. John 21:16 "He saith to him again the second time, Simon, son of Jonas, lovest thou me? He saith unto him, Yea, Lord; thou knowest that I love thee. He saith unto him, Feed my sheep." Peter, do you love me, Jesus, with a Godly, sacrificial, willing to put me first love, I love, phileo, you Jesus as a friend. Why is the

Lord asking Peter this, because this is the man who just a few days earlier told everyone he is willing to die for Jesus, only to turn around and deny Him. It takes a Godly love for someone to be willing to lay their life down for them, to give up what you want in life to serve them the way God does us. Here is the final time Christ ask Peter about his love for Him, John 21:17 "He saith unto him the third time, Simon, son of Jonas, lovest thou me? Peter was grieved because he said unto him the third time, Lovest thou me? And he said unto him, Lord, thou knowest all things; thou knowest that I love thee. Jesus saith unto him, Feed my sheep." Though the third time Jesus ask Peter, the Lord says it as the phileo type of love, it is not too far in the distant future when Peter finally understands and shows forth Agape love by standing up on the day of Pentecost to proclaim the Gospel message risking his life for Christ and truly beginning his ministry. The Apostle Peter used the Agape love several times in 1 Peter. In 1 Peter 1:22 we see he tells us to love the brethren with the Agape love. "Seeing ye have purified your souls in obeying the truth through the Spirit unto unfeigned love of the brethren, see that ye love one another with a pure heart fervently." Even the Apostle Paul used the word to tell husbands how they
