SUMMARY OF ORDINANCE NO. S-588

On May 28, 2026, the governing body of the City of Chanute, Kansas passed an ordinance entitled:

AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION REFUNDING AND IMPROVEMENT BONDS, SERIES 2026-A, OF THE CITY OF CHANUTE, KANSAS; PROVIDING FOR THE LEVY AND COLLECTION OF AN ANNUAL TAX FOR THE PURPOSE OF PAYING THE PRINCIPAL OF AND INTEREST ON SAID BONDS AS THEY BECOME DUE; AUTHORIZING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH; AND MAKING CERTAIN COVENANTS WITH RESPECT THERETO.

The Series 2026-A Bonds approved by the Ordinance are being issued in the principal amount set forth therein to finance certain improvements in, and to refund previously issued general obligation bonds of, the City, and constitute general obligations of the City payable as to both principal and interest, to the extent necessary, from ad valorem taxes which may be levied without limitation as to rate or amount upon all the taxable tangible property within the territorial limits of the City. A complete text of the Ordinance may be obtained or viewed free of charge at the office of the City Clerk, City Hall, 101 S. Lincoln, P.O. Box 907, Chanute, Kansas 66720-0907. 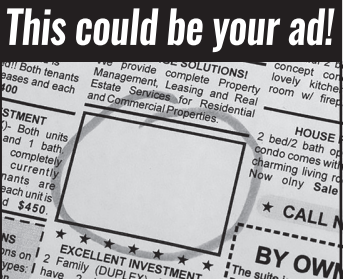

The City of Parsons will hold a public hearing on Monday, June 15, 2026, at 6:00 P.M. or as soon thereafter at City Hall, 112 S 17th, for the purpose of evaluating the performance of Grant No. 23-PF-018 which was for Parsons Public Library Improvements. This project proposed to remove two 20' x 16' sloped windows on the east and south sides of the building and replace with two redesigned non-sloped 20' x 12' windows.

The project accomplished the removal of the two sloped windows and replaced with vertical windows and new roof system in both the east and south locations. 200 square feet of additional interior space was provided, which allowed for two reservable quite rooms in the east window area and an enlarged lounge area in the south window area. This grant was funded, all or in part, from the Kansas Department of Commerce, Small Cities Community Development Block Grant (CDBG) funds. All aspects of the grant will be discussed, and oral and written comments will be recorded and become a part of the City of Parsons CDBG Citizen Participation Plan.

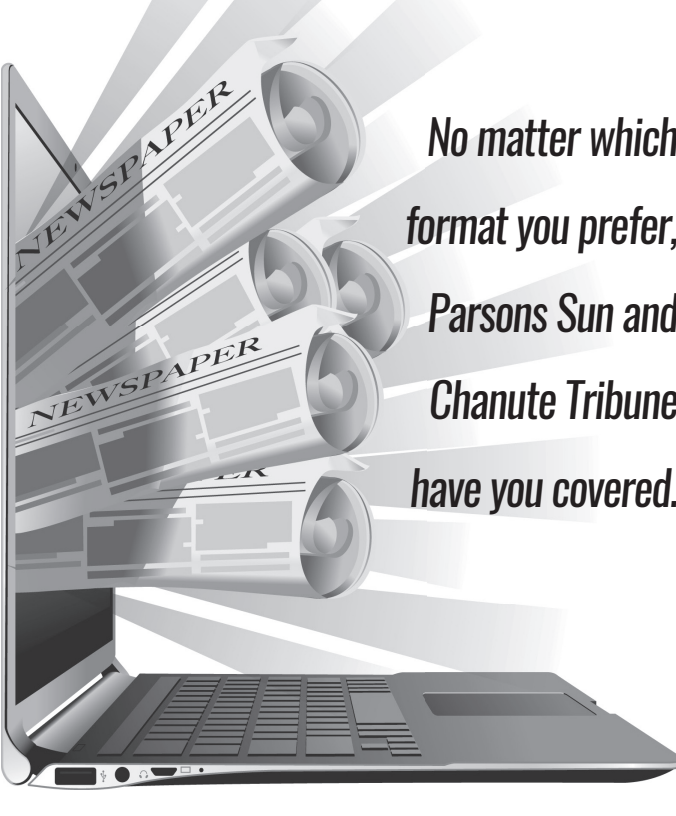
