Notice is hereby given that so much of each tract of land or town lot described in the following list located in Montgomery County, Kansas, as may be necessary for the purpose, will be on the first Tuesday of September, 2026, for the taxes and charges thereon for the year of 2025 be transferred by the Montgomery County Treasurer at the treasurer's office at Montgomery County Courthouse in Independence, Kansas, to the tax sale book, pursuant to Kansas Statutes 79-2302 and 79-2303. State law requires a publication fee of \$16.00 be assessed against each name listed.

Some of the names listed below in this legal publication may have already paid their real estate taxes or may be awaiting results of a tax protest hearing before paying second half taxes due. Unfortunately, it is impossible to delete those names from publication because of statutory requirements.

Although these procedures are required by law, I regret any undue embarrassment this publication may cause those who have paid their taxes after the publication or list preparation deadlines or who are still awaiting tax protest decisions.
